Maintenance Fees

The Industrial Property Office of the Slovak Republic charges the maintenance fees for a patent, for an European patent with the designation of the Slovak Republic, for a supplementary protection certificate for medicinal products and for a plant protection products according to the **Act No 495/2008 Coll.**

Payment of maintenance fees shall be made by **money order** or **transfer** to the bank account. Payments of maintenance fees are made **without** prior notice and are due at the date, when the previous year of validity expires, at the latest.

Variable symbol:

Variable symbol is always created of 10-digit number code. This code starts from the left side with 1digit prefix **X** specifying relevant type of an application/request as follows:

1	PP	(patent application)
4	PDO	(request for supplementary protection certificate)
9	EP	(translation of patent claims of European patent application, translation of European patent file and maintenance fees for European patent)

Prefix X is followed by 9-digit number of an application/request, granted by the Office.
In the case of maintenance fees for patents and supplementary protection certificates (prefixes: 1, 4) the number of an application/request shall have a following form: n5 n4 n3 n2 n1 – YYYY

Where:

n5 n4 n3 n2 n1 - 5-digit code for upward line of numbers of relevant application/request (starts with 00000 every year);

YYYY - 4-digit code for the year of filing of relevant application/request

When creating a variable symbol it is necessary to start from the number of the relevant application/request.

Variable symbol starts from the left with relevant prefix **X** followed by 5-digit code **n5 n4 n3 n2 n1** for upward line of numbers of relevant application/request. This code is followed with 4-digit code **YYYY** for the year of filing of relevant application/request.

Note: Code with less than 5 digit **n5 n4 n3 n2 n1** of an application/request shall be completed with zeros from the left. (E.g. number 21 shall be related to 5-digit code 00021, number 5011 shall be related to 5-digit code 05011.)

Number's form of a national application/request:**n5 n4 n3 n2 n1 - YYYY**Variable symbol composition:**X n5 n4 n3 n2 n1 Y Y Y**

In case of maintenance fees for European patents (prefix 9) the number form of granted European patent shall be as follows: **EP n7 n6 n5 n4 n3 n2 n1**

Where:

n7 n6 n5 n4 n3 n2 n1 is 7-digits code for upward line of numbers of relevant granted European patent

Variable symbol starts from the left with prefix 9, then from the right starts 7-digit code **n7 n6 n5 n4 n3 n2 n1** for upward line of numbers of relevant granted European patent. Remaining empty places shall be completed with zeros from the left.
